Opportunities

- Overall good infrastructure (International Airports, Container Ports, etc.)
- Skilled labour force
- Well developed industrial estates available
- Up to 8 years corporate income tax holidays, import duty exemptions and other incentives for Board of Investment promoted companies
- Board of Investment promoted companies are permitted to own land
- Favourable income tax laws allow tax planning for regionally active professionals
- Various tax treaties in place with other countries

Challenges

- Foreign Business Act imposes restrictions on foreign investments (particularly if related to retail trading)
- Corporate structures using Thai trustees to facilitate foreign investment are prohibited and considered a criminal offence
- Foreign ownership of land is not permitted (except for Board of Investment promoted companies/investments within industrial estates)
- Political tensions still not entirely resolved
