



## Legal Update Week 29 - 30 (13 – 26 July 2020)

### Thailand legal news

#### Highlights:

- BOI grants 1 year an import duty exemption on goods imported for R&D
- Prescribe the duty and obligation of data controllers under Personal Data Protection Act
- Permission of some types of foreigners to stay in Thailand.

- **22 July 2020:**
  - The specific groups of foreigners including businessmen and specialists under special arrangements and diplomats are approved to enter the country ordered by the Centre for Covid-19 Situation Administration (CCSA). However, those groups are required to be under the state quarantine measure.
- **24 July 2020:**
  - The government plans to issue 15-years green bonds amounting to THB 30 billion selling to investors in August in order to assist the financial situation resulting from the Covid-19 outbreak.
- **25 July 2020:**
  - The registration for the “We Tour Together” promotion program started on 15 July 2020 which is enabled for Thai tourists to enjoy 40% discount on hotel prices (up to THB 3,000 per applicant) together with airfares and food expenses.

## New Cabinet resolutions

### 14 July 2020:

- **Approved principle:** Draft Min. reg. issue no. ... (B.E. ...) in accordance with the signboard tax act B.E. 2510
  - Prescribed the new rate of signboard tax from 1 January 2021 to 31 December 2023.

### 21 July 2020:

- **Approved Draft:** Draft Min. reg. re: waiver of fee for license and substitute license in relation to industrial products B.E. ... proposed by the Ministry of Industry.
  - Impose a waiver of fee for license and substitute license in relation to industrial products;
  - Enforcing after 15 days since the date of its publication in the Government Gazette until 30 April 2021.
- **Approved Draft:** Draft Min. reg. re: waiver of fee for examiner and certifier B.E. ... proposed by the Ministry of Industry.
  - Impose the waiver of application fee for a license, certificate, certificate of examination, substitute license, renewal of license, and certification;
  - Enforcing after 15 days since the date of its publication in the Government Gazette until 30 April 2021.
- **Approved Draft:** Draft ministry announcement re: permission of the types of foreigners to stay in the Kingdom under the specific circumstance (issue no. ...)
  - Extend the period of permission to stay under section 35 of the immigration act B.E. 2522 and relevant regulations from 1 August 2020 to 26 September 2020.
  - Extend the period of notifying the place of accommodation under section 37(5) of immigration act B.E. 2522 from 1 August 2020 to 26 September 2020.
